### RULES & GUIDELINES

As candidate, you officially become Mrs. Classic USA 2026 pageant ambassador until the end of the competition. You will maintain a good image and or good moral character. Nudity, inappropriate vulgarity, and any arrest or conviction of crime is subject to disqualification from the pageant. You shall comply under the direction of the pageant director/owner, Romelette Metz, or pageant communications director and/or committee.

Mrs. Classic USA 2026 is a beauty, brain, and talent competition. You will be participating People’s Choice Award, Brand Ambassador Award, Production Dance Number, Talent, Swimwear, Evening Gown and Question and Answer competitions. The cash grand prize for the *winner is \$2000.00, a sash, and a handcrafted silver metal and platinum plated Swarovski crystals crown.*

**Minimum Requirements:** *Pay Entry Fee. You may sell 5 Tickets and at least one Sponsor or Ads to be eligible for the Brand Ambassador Award competition.*

**Mandatory Activities include:** *Orientation (ZOOM), Pre-Pageant Talent Night, Photoshoot, Rehearsal, Pageant and Grand Coronation Night. Red carpet and pageant promotional appearances are optional, however, it is strongly encouraged.*

### **Our Scoring System**

You will be scored prior to pageant night on the following categories:

1. **Pre-Pageant Talent Night.** You are required to perform in person on our scheduled Talent Night on **August 14, 2026** (venue TBD). Limit performance to 3:30. 2 points will be taken off if it is too long (3:30>) or too short (<3:00). The TOP 5 candidates will be announced to compete for the Best in Talent on Pageant Night.
2. **People's Choice Award** through free online public voting. 10 POINTS
3. **Brand Ambassador Award.** Highest paid online voting & ticket & ad sales. 10 POINTS

Mrs. Classic USA 2026 Pageant Night, August 15, 2026, Saturday, 5pm-10:00pm, at the **San Antonio Marriott Northwest Medical Center, 3233 NW Loop 410, San Antonio, Tx. 78213**, you will be scored on the following categories:

1. **Production Dance Number and Introduction.** 10 POINTS
2. **Best in Talent Competition.** 20 POINTS
3. **Swimwear Competition.** 10 POINTS
4. **Evening Gown Competition.** 15 POINTS
5. **Question and Answer.** 25 POINTS

*NOTE: We will have an independent accountant and Chairman of the Board of Judges to ensure no errors will be made.*

### **AGREEMENT** (Please initial):

\_\_\_\_\_ I agree that while competing on this pageant, I will not join any other pageant until this pageant is over. I can attend other pageant events but cannot endorse or sign up as candidate.

\_\_\_\_\_ I agree that if crowned as Mrs. Classic USA 2026, I cannot join any pageant until my royalty term is over which is 12 months after the coronation night. And if a national pageant opportunity arises, I will be competing to represent Texas.

\_\_\_\_\_ I agree and understand that if I'm unable to sell 5 tickets and at least one sponsor or ad, the highest score I will get for the Brand Ambassador Special Award is 5 Points.

\_\_\_\_\_ I hereby represent and affirm that I am of the natural born woman and I have not been convicted of any crime, whether designated a felony or misdemeanor, in any state of the United States or in any foreign countries. I understand that my participation in Mrs. Classic USA 2026 is subject to satisfying all conditions for acceptance and participation as contestant set forth in the Rules and Regulations. I further understand and agree that the decision on my acceptance as a candidate will be by pageant director, Fil-Am World Magazine, and pageant committee in its sole and unfettered discretion and not subject to challenge or appeal.

\_\_\_\_\_ I am aware that I can run my own fundraiser events to support my campaign for the pageant and the type of event/s and promotional materials require an approval from Romelette Metz to ensure appropriate branding. I understand to pay a royalty fee of 15% of the gross revenue to Romelette Metz/Fil-Am World Magazine.
